PLAN COMMISSION RESOLUTION NO. 2009-09-08**

**A RESOLUTION ADOPTING AND RECOMMENDING THE COMPREHENSIVE PLAN
FOR THE CITY OF VERONA IN DANE COUNTY, WISCONSIN**

WHEREAS, Wisconsin Statutes 62.23 authorizes the adoption of a Comprehensive Plan for the general purpose of guiding and accomplishing a coordinated, adjusted, and harmonious development of the municipality which will, in accordance with existing and future needs, best promote the public health, safety, and the general welfare, as well as efficiency and economy in the process of development; and

WHEREAS, the City of Verona Comprehensive Plan has been prepared by the City of Verona Comprehensive Plan Committee—in consultation with City of Verona staff, the Plan Commission, the Common Council—in accordance with the requirements and elements of State Statute Section 66.1001 (Comprehensive Planning) enacted in 1999; and

WHEREAS, the Comprehensive Plan Committee provided ample, meaningful and diverse opportunities for citizen input and participation throughout the process of drafting the Comprehensive Plan, including distribution of draft chapters to identified ‘stakeholders’; comment cards; four open houses, three surveys, news articles, and other methods; and

WHEREAS, the City of Verona Comprehensive Plan contains data, maps, goals, objectives, and policies for elements required in Wisconsin State Statute Section 66.1001 including issues and opportunities; housing; transportation; utilities and community facilities; natural and cultural resources; agriculture and economic development; intergovernmental cooperation; land use; and implementation; and

WHEREAS, the City of Verona Comprehensive Plan has been reviewed and recommended for approval by the Comprehensive Plan Committee on May 18th, 2009; and

WHEREAS, the City of Verona Plan Commission held a public hearing on the 8th day of September, 2009 to give an opportunity for public comment on the Comprehensive Plan, and said public hearing was preceded by the Class 1 legal notice required in State Statute Section 66.1001(4)(d) and said public hearing was preceded by the mailed notification required in State Statute Section 66.1001(4)(e).



BE IT FURTHER RESOLVED that the City of Verona Plan Commission hereby recommends that the Common Council approve Ordinance 09-775, an Ordinance to Adopt the Comprehensive Plan of the City of Verona, Wisconsin.


